- One letter of reference from a faculty member. It is suggested that the letters reflect not only the student's academic ability, but their character, study and work habits and motivation to show the student's overall potential. The reference letter should be sealed by the writer of the reference.
- An essay stating why you chose to attend Texas A&M University
